Initial Joining Fee	\$100 (one time fee payable only in first year)
Annual Membership Fee	\$50
Pheasant unit (10 birds minimum)	\$250 + hst
Additional pheasant unit (5 birds)	\$125 + hst
Waterfowl ducks only	\$250
Goose hunting upgrade	\$150

This year, unfortunately, we have to charge hst on released birds, otherwise prices for birds have been maintained at last season's level. We have separated out organised blind shooting for geese from the waterfowl option. This option must be added to a waterfowl option if one would like to participate in club organised blind shoots for geese that occur outside of the normal duck hunting season. Members may take a goose from a duck blind without this option during the normal duck season if federal hunting rules permit.

Pheasants (2 Chukar equivalents) may be purchased in a minimum quantity of ten; add more birds in multiples of five, e.g. 10, 15, 20.

Junior member fee	\$160 (see regulations)
Guest for walk-up shoot	\$10 (per day)
Guest for Waterfowl shoot	\$50 (per day)
Guest for Old Country Shoot	\$50 (per day)
Extra bird	\$25 + hst (1 Pheasant or 2 Chukars)
